



## **Options**

- 1. Require health plans to oversee the sub-delegated RBOs in the same way they oversee direct contracted RBOs.
- 2. Require health plans to include in their contracts with RBOs that if they are going to sub-delegate, they must include the same requirements.
- 3. Prohibit sub-delegation.
