Proposed Transaction

- Centene Corporation to buy Magellan Health, Inc. for \$2.2 billion.
- Centene Corporation will become the owner of two DMHC licensed plans, Human Affairs International of California (HAI-CA) and Magellan Health Services of California, Inc. - Employer Services (MHSC).

Centene Corporation

- Fortune 500 company
- National insurer based in Missouri
- Largest provider of government-sponsored health plans in the United States

- Magellan Health Services of California, Inc. – Employer Services (MHSC)


Human Affairs International of California

Magellan Health Services of California – Employer Services

- California Corporation
- Licensed by the DMHC in 1987
- Offers Employee Assistance Programs (EAP)
- Approximately 1.3 million enrollees

Licensing Review Process

The Director determined that this is a “major transaction” under Section 1399.65 of the Knox Keene Act, which requires:

- An independent analysis to evaluate the impact of the transaction on subscribers and enrollees and the stability of the health care delivery system, including an assessment of whether this transaction would substantially lessen competition in healthcare plan products or create a monopoly in California.
- A public meeting and opportunity for public comment.

Licensing Review Process

Review of the Proposed Change of Control includes:

- Organizational and corporate changes
- Any administrative capacity issues
- Changes to how services will be delivered
- Changes to how the plan contracts with other plans and with providers
- Any other potential impact to enrollees

Financial Review Process

Review of the Proposed Change of Control includes:

- Financial projections from HAI-CA and MHSC
- Likely impact on HAI-CA and MHSC's:
 - Finances
 - Staffing, services performed and organizational structure
 - Assigned enrollment
