

## DMHC Financial Solvency Standards Board (FSSB) Board Member Solicitation

The Department of Managed Health Care (DMHC) is seeking a dynamic and solution-oriented healthcare professional to serve on the DMHC Financial Solvency Standards Board (FSSB). The FSSB meets quarterly to advise the Director on matters of financial solvency that affect the delivery of health care services. The Board reviews periodic reports related to plan operations and makes recommendations to the Director related to financial solvency requirements, standards, and regulations. Members are appointed by the Director for a term of three years.

- Medical and health care economics
- Accountancy, with experience in integrated or affiliated health care delivery systems
- Excess loss insurance underwriting in the medical, hospital, and health plan business
- Actuarial studies in the area of health care delivery systems
- Management and administration in integrated or affiliated health care delivery systems
- Investment banking
- Information technology in integrated or affiliated health care delivery systems
