SUBJECT: APL 20-012 – Health Plan Actions to Reach Vulnerable Populations

The coronavirus poses a serious risk to California's most vulnerable populations, including people over 65 years of age, people with chronic conditions, and those with disabilities. People in these groups are at an increased risk of developing severe complications or dying from the coronavirus

Health care service plans should be actively engaging with enrollees in these groups to ensure the enrollees continue to receive the care they need, while practicing appropriate social distancing.

To demonstrate health plans are taking appropriate steps, by the end of the day on **Tuesday, March 31, 2020**, each health plan to which this All Plan Letter applies shall file with the Department of Managed Health Care (DMHC):

- 1. A description of the steps the health plan has taken or is taking to contact (1) enrollees over age 65; (2) enrollees with chronic conditions; and (3) enrollees with disabilities; to ensure these individuals continue to receive needed health care services, while practicing appropriate social distancing;
- 2. A description of approximately how many enrollees the health plan has contacted in each category (over 65, with chronic conditions, with disabilities). The DMHC understands some enrollees may fall into more than one category. For purposes of this report, a health plan should count an enrollee only once, rather than double or triple count enrollees who fall into more than one category.

Submit the above-described information through the DMHC's eFiling portal as a "Report/Other," titled "COVID-19 Report Re: Vulnerable Populations." The information should be included in an Exhibit E-1.
